

WHOLESALE PARTNER AGREEMENT

Journeys of Women Ministries LLC

This Wholesale Partner Agreement ("Agreement") is entered into between Journeys of Women Ministries LLC ("Company") and the approved Wholesale Partner ("Retailer").

By purchasing products at wholesale pricing from Journeys of Women Ministries LLC, the Retailer agrees to the following terms and conditions.

1. PURPOSE

This Agreement establishes the terms under which the Retailer may purchase products from Journeys of Women Ministries LLC at approved wholesale pricing for resale to consumers.

2. WHOLESALE ELIGIBILITY

Wholesale pricing is available only to approved businesses.

Approval is granted at the sole discretion of Journeys of Women Ministries LLC.

The Company reserves the right to deny or revoke wholesale privileges at any time.

3. PRODUCT RESALE

Wholesale products purchased under this Agreement are intended for resale only.

Retailers may sell products through:

- Physical retail stores
- Boutiques
- Gift shops
- Christian stores
- Vendor events
- Farm stores
- Online retail websites

Retailers may not represent themselves as owners, creators, or manufacturers of the products.

4. MINIMUM ADVERTISED PRICING

Retailers agree not to advertise products below their purchased wholesale cost.

Journeys of Women Ministries LLC reserves the right to discontinue wholesale relationships with retailers who engage in excessive discounting that damages the brand.

5. PRODUCT IMAGES

Approved retailers may use authorized product images provided by Journeys of Women Ministries LLC.

Images may be used only for the promotion and sale of approved products.

Images may not be altered in a manner that misrepresents the products.

All product images remain the property of Journeys of Women Ministries LLC.

6. ORDERING

Wholesale orders are subject to product availability.

The Company reserves the right to discontinue, modify, or replace product designs and collections at any time.

Lead times may vary depending on product demand and production schedules.

7. PAYMENT TERMS

Payment is required prior to shipment unless otherwise agreed upon in writing.

Accepted payment methods may include:

- Credit Card
- PayPal
- Approved electronic payment methods

Orders will not be processed until payment has been received.

8. SHIPPING

Shipping charges will be added to wholesale orders unless otherwise stated.

Shipping times are estimates and are not guaranteed.

Journeys of Women Ministries LLC is not responsible for delays caused by carriers, weather events, or circumstances beyond its control.

9. RETURNS AND DAMAGES

Retailers must inspect shipments upon receipt.

Damaged items must be reported within seven (7) calendar days of delivery.

Photographs of damaged products and packaging may be required.

Because products are handcrafted, slight variations in color, texture, and appearance are considered normal and are not considered defects.

10. INTELLECTUAL PROPERTY

All product designs, branding, logos, photographs, marketing materials, and related content remain the exclusive property of Journeys of Women Ministries LLC.

Retailers may not reproduce, copy, manufacture, or distribute products without written permission.

11. TERMINATION

Either party may terminate this Agreement at any time.

Journeys of Women Ministries LLC reserves the right to terminate wholesale privileges immediately for:

- Violation of this Agreement
- Misrepresentation of products

- Unauthorized use of intellectual property
 - Fraudulent activity
 - Failure to make required payments

12. LIMITATION OF LIABILITY

Journeys of Women Ministries LLC shall not be liable for indirect, incidental, consequential, or special damages arising from the sale or use of products.

The Retailer's sole remedy shall be limited to the purchase price of the affected products.

13. GOVERNING LAW

This Agreement shall be governed by and interpreted under the laws of the State of Florida.

Any disputes shall be resolved in the appropriate courts located within the State of Florida.

14. ENTIRE AGREEMENT

This document represents the entire agreement between the parties and supersedes all prior discussions or understandings relating to wholesale purchases.

Any modifications must be made in writing and approved by both parties.
